Course Description: This course will cover basic geography, civics and government, economic concepts while studying ancient civilizations. The class will also focus on reading, writing, and thinking critically about history.

- Gather, interpret, document, and use information from multiple sources and diverse media, distinguish facts from opinions while recognizing points of view through inquiry and research.
- Critique information by determining its sufficiency to answer questions and if the source is credible.
- Construct arguments using claims and evidence from multiple sources, while acknowledging the strengths and limitations of these arguments.

Notification of the Right to Object to the Use of Materials
